### **SECTION 1. PURPOSE.**

The purpose of this Request for Proposal (RFP) is to receive competitive offers and establish a contract for installation of a basement/crawl space drainage system by a qualified licensed company.

## **SECTION 2. BACKGROUND**

The existing crawl space is holding moisture due to run off and ground water entering the crawl space of the residence.

## **SECTION 3. SCOPE OF SERVICES.**

Installation of a crawl space drainage system to include drainage matting in order to prevent ground water from seeping through, installation of a sump pump system with liner, and dehumidifier.

## **SECTION 4. PROPOSAL PREPARATION AND SUBMISSION INSTRUCTIONS**

Proposals must be submitted in accordance with the instructions and requirements given in this RFP, including the cover page. All information requested must be submitted. Failure to do so may result in the proposal being considered non-responsive and it may be rejected.

Your proposal, one (1) original and five (3) copies, including the cover page of this RFP signed by an authorized representative of your firm, must be submitted in a sealed envelope or package. The notation "**CONFIDENTIAL – Crawl Space Drainage System**" must be clearly marked on the front of that sealed envelope or package.

AHCS and its officers, employees or agents will not be responsible for the opening of a proposal envelope or package prior to the scheduled opening if that envelope or package is not appropriately sealed and marked as specified.

AHCS reserves the right to cancel this RFP and/or reject any or all proposals, to waive informalities in any proposal, to award any whole or part of a proposal, and to award to the Offeror whose proposal is, at the sole discretion of AHCS, determined to be in the best interest of AHCS.

Proposal evaluation and award will be accomplished in accordance with this RFP and applicable law. If an award of a contract is made, notification of such award will be provided to the Offeror and posted for public review on the AHCS website at [www.ahcsb.org](http://www.ahcsb.org).

No proposal may be withdrawn for a period of sixty (60) days after the opening of the proposal.

This RFP consists of this Introduction, the numbered sections, and the attachments hereto.

**AHCS is not responsible for any copies of this RFP obtained from any source other than AHCS.**

## **Instructions for Offerors:**

At a minimum, prospective Offerors are to include the items below as part of their proposal. Each proposal should include a transmittal letter and table of contents. The proposal should be no more than 20 pages, single spaced and typed (one side only) in length.

Proposals must include the following:

1. Experience: A narrative describing the firms' experience and qualifications. Some of the information required includes, but is not necessarily limited to, length of time in the business, experience, strengths, business philosophy; a description of how the firm will perform the services listed in the scope of services of this Request for Proposal, including the names, titles, and qualifications of the individuals that will be working directly with AHCS.
2. References: References from a minimum of three (3) previous clients within the last five (5) years, preferably local government clients.
3. Outline of Services: An outline of the services to be performed and identification of who will perform the service.
4. Fees: Describe all fees required for the performance of the requested services.
5. Pre-bid Meeting: There will be a mandatory pre-bid meeting at the Alleghany Highlands Community Services Guinan Center, 311 Monroe Avenue, Covington, Virginia, held by Ingrid Barber and Patty Flanagan on Wednesday, September 5, 2018 at 3:00 PM in order to assist bidders in preparing their bid packages. Any interested bidder should arrive by the specified time in order to view the site. We are requesting bidders to provide their own ladder for review and inspection. No additional pre-bid meetings will be provided. Bidders should notify the buyer on the face of this Invitation for Bid in advance if they intend on attending the pre-bid meeting.

## **SECTION 5. EVALUATION CRITERIA.**

Offerors will be evaluated for selection on the basis of those most qualified to meet the requirements of this RFP. Criteria to be considered in evaluation include the following:

- A. The background and experience of the offeror, including the level of experience in working with municipalities and the quality of services performed.
- B. The proposal submitted by the offeror for completeness, attention to detail, and strategy.
- C. References from previous clients.

## **SECTION 6. SELECTION PROCESS.**

The method of selection of the successful offeror shall be through competitive negotiation.

- A. All proposals submitted in response to this RFP will be reviewed for responsiveness prior to referral to the selection committee. The award, if made, will be made to the offeror whose proposal best furthers the interest of AHCS. AHCS reserves the right to reject any and all proposals, to waive any informality or irregularity in the proposals received, and to make the award to the offeror whose proposal is deemed to be in the best interest of AHCS. The award, if one is made, will be a contract incorporating the terms and conditions contained in this RFP.
- B. Offerors who submit a proposal in response to this RFP may be required to give an oral presentation of their proposal to the selection committee. This provides an opportunity for the offeror to clarify or elaborate on the proposal. This is a fact finding and explanation session only and does not include negotiation. Oral presentations are strictly at the option of AHCS and may or may not be conducted.

#### SECTION 7. MISCELLANEOUS.

- A. Ownership of Material - Ownership of all data, materials, and documentation originated and prepared for AHCS pursuant to the RFP shall belong exclusively to AHCS and be subject to public inspection in accordance with the *Virginia Freedom of Information Act*. Trade secrets or proprietary information submitted by the offeror shall not be subject to public disclosure under the *Freedom of Information Act*, unless otherwise required by law or a court. **However, the offeror must invoke the protection of Section 2.2-4342(F) of the Code of Virginia, in writing, either before or at the time the data or other material is submitted.** The written notice must SPECIFICALLY identify the data or materials to be protected and state the reason why protection is necessary. The proprietary or trade secret material submitted must be identified by some distinct method such as highlighting or underlining and must indicate only the specific words, figures, or paragraphs that constitute trade secret or proprietary information. The classification of an entire proposal document, line item prices, and/or total proposal prices as proprietary, or trade secrets, is NOT ACCEPTABLE and may result in REJECTION of the proposal.
- B. As this is a RFP, no information regarding the proposal records or the contents of responses will be released except in accordance with Section 2.2-4342 of the Code of Virginia. Once an award has been made, all proposals will be open to public inspection subject to the provisions set forth above.
- C. Any interpretation, correction, or change of the RFP will be made by an addendum. Interpretations, corrections or changes of this RFP made in any other manner will not be binding and offerors must not rely upon such interpretations, corrections, or changes.
- D. No offeror shall confer on any AHCS employee having official responsibility for a purchasing transaction any payment, loan, subscription, advance, deposit or money,

service, or anything of more than nominal value, present or promised, unless consideration of substantially equal or greater value is exchanged.

- E. AHCS may make investigations to determine the ability of the offeror to perform or supply the services and/or items as described in this RFP. AHCS reserves the right to reject any proposal if the offeror fails to satisfy AHCS that it is qualified to carry out the obligations of the proposed contract.

## **SECTION 8. GENERAL TERMS AND CONDITIONS.**

- A. **Acceptance of Bids/Proposals:** Unless otherwise specified, all bids/proposals submitted shall be valid for a minimum period of 60 calendar days following the date established for receiving bids/proposals. At the end of the 60 calendar days the bid/proposal may be withdrawn at the written request of the bidder/proposer. If the bid/proposal is not withdrawn at that time it remains in effect until an award is made or the solicitation is cancelled.
- B. **Anti-Discrimination:** By submitting their proposals, proposers certify to AHCS that they will conform to the provisions of the Federal Civil Rights Act of 1964, as amended, as well as the Virginia Fair Employment Contracting Act of 1975, as amended, where applicable, the Virginians With Disabilities Act, the Americans With Disabilities Act and § 2.2-4311 of the Virginia Public Procurement Act (VPPA). If the award is made to a faith-based organization, the organization shall not discriminate against any recipient of goods, services, or disbursements made pursuant to the contract on the basis of the recipient's religion, religious belief, refusal to participate in a religious practice, or on the basis of race, age, color, gender or national origin and shall be subject to the same rules as other organizations that contract with public bodies to account for the use of the funds provided; however, if the faith-based organization segregates public funds into separate accounts, only the accounts and programs funded with public funds shall be subject to audit by the public body. (*Code of Virginia*, § 2.2-4343.1E).

In every contract over \$10,000 the provisions in 1 and 2 below apply:

- 1. During the performance of this contract, the contractor agrees as follows:
  - a. The contractor will not discriminate against any employee or applicant for employment because of race, religion, color, sex, national origin, age, disability, or any other basis prohibited by state law relating to discrimination in employment, except where there is a bona fide occupational qualification reasonably necessary to the normal operation of the contractor. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this nondiscrimination clause.
  - b. the contractor, in all solicitations or advertisements for employees placed by or on behalf of the contractor, will state that such contractor is an equal opportunity employer.
  - c. Notices, advertisements and solicitations placed in accordance with federal law, rule or regulation shall be deemed sufficient for the purpose of meeting these requirements.

2. The contractor will include the provisions of 1 above in every subcontract or purchase order over \$10,000, so that the provisions will be binding upon each subcontractor or vendor.
- C. **Antitrust:** By entering into a contract, the contractor conveys, sells, assigns, and transfers to AHCS all rights, title and interest in and to all causes of action it may now have or hereafter acquire under the antitrust laws of the United States and the Commonwealth of Virginia, relating to the particular goods or services purchased or acquired by AHCS under said contract.
- D. **Applicable Laws and Courts:** This solicitation and any resulting contract shall be governed in all respects by the laws of the Commonwealth of Virginia and any litigation with respect thereto shall be brought in the appropriate court in Alleghany County, Virginia. The Contractor shall comply with federal, state and local laws and regulations.
- E. **Assignment of Contract:** A contract shall not be assignable by the contractor in whole or in part without the written consent of AHCS.
- F. **Availability of Funds:** It is understood and agreed between the parties herein that AHCS shall be bound hereunder only to the extent of the funds available or which may hereafter become available for the purpose of this agreement.
- G. **Bid/Proposal Pricing:** The bid/proposal price shall be an all-inclusive price to deliver the specified goods and/or services FOB Destination to the address specified per the specifications. Invoices must be itemized and will be paid at the unit price in the bid/proposal. AHCS will not accept or pay for additional line items such as freight, shipping and handling, delivery, downtime, equipment, lost time due to inclement weather or any other charges additional to the unit prices quoted in the bid/proposal.
- H. **Changes to the Contract:** Changes can be made to the contract in any of the following ways:
1. The parties may agree in writing to modify the scope of the contract. An increase or decrease in the price of the contract resulting from such modification shall be agreed to by the parties as a part of their written agreement to modify the scope of the contract.
  2. AHCS may order changes within the general scope of the contract at any time by written notice to the contractor. Changes within the scope of the contract include, but are not limited to, things such as services to be performed, the method of packing or shipment, and the place of delivery or installation. The contractor shall comply with the notice upon receipt. The contractor shall be compensated for any additional costs incurred as the result of such order and shall give AHCS a credit for any savings. Said compensation shall be determined by one of the following methods:
    - a. By mutual agreement between the parties in writing; or  
By agreeing upon a unit price or using a unit price set forth in the contract, if the work to be done can be expressed in units, and the contractor accounts for the number of units of work performed, subject to AHCS's right to audit the contractor's records and/or to determine the correct number of units independently; or
    - b. By ordering the contractor to proceed with the work and keep a record of all costs incurred and savings realized. A markup for overhead and profit may be allowed if provided by the contract. The same markup shall be used for determining a decrease in price as the result of savings realized.

The contractor shall present AHCS with all vouchers and records of expenses incurred and savings realized. AHCS shall have the right to audit the records of the contractor as it deems necessary to determine costs or savings. Any claim for an adjustment in price under this provision must be asserted by written notice to AHCS within thirty (30) days from the date of receipt of the written order from AHCS. If the parties fail to agree on an amount of adjustment, the question of an increase or decrease in the contract price or time for performance shall be resolved in accordance with the procedures for resolving disputes provided by the Disputes Clause of this contract or, if there is none, in accordance with the disputes provisions of the VPPA. Neither the existence of a claim nor a dispute resolution process, litigation, or any other provision of this contract shall excuse the contractor from promptly complying with the changes ordered by AHCS or with the performance of the contract generally.

- I. **Claims:** Contractual claims, whether for money or other relief, shall be submitted in writing to AHCS, Administrative Office, 205 E. Hawthorne Street, Covington, Virginia 24426, no later than sixty (60) days after final payment; however, written notice of the contractor's intention to file such claim shall have been given at the time of the occurrence or beginning of the work upon which the claim is based. Nothing herein shall preclude a contract from requiring submission of an invoice for final payment within a certain time after completion and acceptance of the work or acceptance of the goods. Pending claims shall not delay payment of amounts agreed due in the final payment (Code of Virginia, Section 2.2-4363). A contractor may not institute legal action prior to receipt of AHCS decision on the claim, unless that office fails to render such decision within thirty (30) days. Failure of AHCS to render a decision within thirty (30) days shall not result in the contractor being award the relief claimed or in any other relief or penalty. The sole remedy for AHCS's failure to render a decision within thirty (30) days shall be the contractor's right to institute immediate legal action. The decision of AHCS shall be final and conclusive unless the contractor, within six (6) months of the date of the final decision of the claim, institutes legal action as provided in the Code of Virginia, Section 2.2-4364.
- J. **Clarification of Terms:** If any prospective bidder/proposer has questions about the specifications or other solicitation documents, the prospective bidder/proposer should contact the buyer whose name appears on the face of the solicitation no later than three (3) working days before the due date. The bidder/proposer may be asked to submit such questions in writing. Any revisions to the solicitation will be made only by addendum issued by the buyer.
- K. **Debarment Status:** By submitting their bids/proposals, bidders/proposers certify that they are not currently debarred by AHCS or the Commonwealth of Virginia from submitting bids/proposals on contracts for the type of goods and/or services covered by this solicitation, nor are they an agent of any person or entity that is currently so debarred.
- L. **Default:** In case of failure to deliver goods or services in accordance with the contract terms and conditions, AHCS, after due oral or written notice, may procure them from other sources and hold the contractor responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies which AHCS may have. In addition, AHCS reserves the right to cancel any orders placed that are not delivered by the date specified in the Invitation to Bid/Invitation for Proposal.

- M. **Drug-Free Workplace:** During the performance of this contract, the contractor agrees to (i) provide a drug-free workplace for the contractor's employees; (ii) post in conspicuous places, available to employees and applicants for employment, a statement notifying employees that the unlawful manufacture, sale, distribution, dispensation, possession, or use of a controlled substance or marijuana is prohibited in the contractor's workplace and specifying the actions that will be taken against employees for violations of such prohibition; (iii) state in all solicitations or advertisements for employees placed by or on behalf of the contractor that the contractor maintains a drug-free workplace; and (iv) include the provisions of the foregoing clauses in every subcontract or purchase order of over \$10,000, so that the provisions will be binding upon each subcontractor or vendor. For the purposes of this section, “*drug-free workplace*” means a site for the performance of work done in connection with a specific contract awarded to a contractor, the employees of whom are prohibited from engaging in the unlawful manufacture, sale, distribution, dispensation, possession or use of any controlled substance or marijuana during the performance of the contract.
- N. **Ethics in Public Contracting:** By submitting their proposals, proposers certify that their proposals are made without collusion or fraud and that they have not offered or received any kickbacks or inducements from any other proposer, supplier, manufacturer or subcontractor in connection with their proposal, and that they have not conferred on any public employee having official responsibility for this procurement transaction any payment, loan, subscription, advance, deposit of money, services or anything of more than nominal value, present or promised, unless consideration of substantially equal or greater value was exchanged.
- O. **Facsimile and Email Proposals:** Facsimile or email unsealed bids/proposals received by AHCS prior to the time and date designated for unsealed bid/proposal submission will be accepted. It is the proposer’s responsibility to ensure these proposals are received by the appropriate person/department at AHCS. Facsimile or email bids/proposals will not be accepted for sealed bids/proposals.
- P. **Immigration Reform and Control Act of 1986:** By submitting their bids/proposals, bidders/proposers certify that they do not and will not during the performance of this contract employ illegal alien workers or otherwise violate the provisions of the federal Immigration Reform and Control Act of 1986.
- Q. **Indemnification:** Contractor agrees to indemnify, defend, and hold harmless AHCS and its officers, agents, and employees from any claims, damages and actions of any kind or nature, whether at law or in equity, arising from or caused by the use of any materials, goods, or equipment of any kind or nature furnished by the contractor or any services of any kind or nature furnished by the contractor, provided that such liability is not attributable to the sole negligence of AHCS or failure of AHCS to appropriately use the materials, good, or equipment delivered.
- R. **Late Bids/Proposals:** To be considered for selection, bids/proposals must be received by the appropriate office at AHCS by the designated date and hour. Bids/Proposals received by AHCS after the date and hour designated are automatically disqualified and will not be considered. AHCS is not responsible for delays in the delivery of mail by the U.S. Postal Service, private couriers, or other means of delivery. It is the sole responsibility of the bidder/proposer to ensure that its proposal reaches AHCS by the designated time and hour.
- S. **Mandatory use of City Form and Terms and Conditions:** Failure to submit a bid/proposal on the official AHCS form provided for that purpose shall be a cause for

rejection of the bid/proposal. Modification of or additions to any portion of the Invitation to Bid/Invitation for Proposal may be cause for rejection of the proposal; however, AHCS reserves the right to decide, on a case by case basis, in its sole discretion, whether to reject such a bid/proposal as nonresponsive. As a precondition to its acceptance, AHCS may, in its sole discretion, request that the bidder/proposer withdraw or modify nonresponsive portions of a bid/proposal which do not affect quality, quantity, price, or delivery. No modification of or addition to the provisions of the contract shall be effective unless reduced to writing and signed by the parties.

- T. **Negotiation with the Lowest Bidder: For City issued invitation for bids (“IFBs”)**, unless all bids are cancelled or rejected, AHCS reserves the right granted by § 2.2-4318 of the *Code of Virginia* to negotiate with the lowest responsive, responsible bidder to obtain a contract price within the funds available to AHCS whenever such low bid exceeds AHCS’s available funds. For the purpose of determining when such negotiations may take place, the term “available funds” shall mean those funds which were budgeted by AHCS for this contract prior to the issuance of the IFB. Negotiations with the low bidder may include both modifications of the bid price and the Scope of Work/Specifications to be performed. AHCS shall initiate such negotiations by written notice to the lowest responsive, responsible bidder that its bid exceeds the available funds and that AHCS wishes to negotiate a lower contract price. The times, places, and manner of negotiating shall be agreed to by AHCS and the lowest responsive, responsible bidder.
- U. **Nondiscrimination of Contractors:** A bidder, proposer, offeror, or contractor shall not be discriminated against in the solicitation or award of this contract because of race, religion, color, sex, national origin, age, disability, faith-based organizational status, any other basis prohibited by state law relating to discrimination in employment. If the award of this contract is made to a faith-based organization and an individual, who applies for or receives goods, services, or disbursements provided pursuant to this contract objects to the religious character of the faith-based organization from which the individual receives or would receive the goods, services, or disbursements, AHCS shall offer the individual, within a reasonable period of time after the date of his objection, access to equivalent goods, services, or disbursements from an alternative provider.
- V. **Payment:**
1. **To Prime Contractor:**
    - a. Invoices for items ordered, delivered and accepted shall be submitted by the contractor directly to the payment address shown on the purchase order/contract. All invoices shall show AHCS contract number and/or purchase order number, if any; social security number (for individual contractors) or the federal employer identification number (for proprietorships, partnerships, and corporations).
    - b. Any payment terms requiring payment in less than 45 days will be regarded as requiring payment 45 days after invoice or delivery, whichever occurs last. This shall not affect offers of discounts for payment in less than 45 days, however.
    - c. All goods or services provided under this contract or purchase order, that are to be paid for with public funds, shall be billed by the contractor at the contract price.
    - c. The following shall be deemed to be the date of payment: the date of postmark in all cases where payment is made by mail, or the date of offset

when offset proceedings have been instituted as authorized under the Virginia Debt Collection Act.

- d. **Unreasonable Charges.** Under certain emergency procurements and for most time and material purchases, final job costs cannot be accurately determined at the time orders are placed. In such cases, contractors should be put on notice that final payment in full is contingent on a determination of reasonableness with respect to all invoiced charges. Charges which appear to be unreasonable will be researched and challenged, and that portion of the invoice held in abeyance until a settlement can be reached. Upon determining that invoiced charges are not reasonable, AHCS shall promptly notify the contractor, in writing, as to those charges which it considers unreasonable and the basis for the determination. A contractor may not institute legal action unless a settlement cannot be reached within thirty (30) days of notification. The provisions of this section do not relieve an agency of its prompt payment obligations with respect to those charges which are not in dispute (*Code of Virginia*, § 2.2-4363).

**2. To Subcontractors:**

- a. A contractor awarded a contract under this solicitation is hereby obligated:
  - (1) To pay the subcontractor(s) within seven (7) days of the contractor's receipt of payment from AHCS for the proportionate share of the payment received for work performed by the subcontractor(s) under the contract; or
  - (2) To notify AHCS and the subcontractor(s), in writing, of the contractor's intention to withhold payment and the reason.
- b. The contractor is obligated to pay the subcontractor(s) interest at the rate of one percent per month (unless otherwise provided under the terms of the contract) on all amounts owed by the contractor that remain unpaid seven (7) days following receipt of payment from AHCS, except for amounts withheld as stated in (2) above. The date of mailing of any payment by U. S. Mail is deemed to be payment to the addressee. These provisions apply to each sub-tier contractor performing under the primary contract. A contractor's obligation to pay an interest charge to a subcontractor may not be construed to be an obligation of AHCS.

**W. Precedence of Terms:** The following General Terms and Conditions: ANTI-DISCRIMINATION, ANTITRUST, APPLICABLE LAWS AND COURTS, CLARIFICATION OF TERMS, DEBARMENT STATUS, ETHICS IN PUBLIC CONTRACTING, IMMIGRATION REFORM AND CONTROL ACT OF 1986, MANDATORY USE OF CITY FORM AND TERMS AND CONDITIONS, AND PAYMENT shall apply in all instances. AHCS reserves the right to inspect (bidder's/proposer's) physical facilities prior to award to satisfy questions regarding the (bidder's/proposer's) capabilities. AHCS further reserves the right to reject any (bid/proposal) if the evidence submitted by, or investigations of, such (bidder/proposer) fails to satisfy AHCS that such (bidder/proposer) is properly qualified to carry out the obligations of the contract and to provide the services and/or furnish the goods contemplated therein.

- Z. **Supremacy Clause:** Notwithstanding any provision in the bidder's/proposer's response to the contrary, the bidder/proposer agrees that the terms and conditions contained in AHCS's proposal prevail over contrary terms and conditions contained in the bidder's/proposer's response.
- AA. **Taxes:** Sales to AHCS are normally exempt from State sales tax. State sales and use tax certificates of exemption will be issued upon request. Deliveries against this contract shall usually be free of Federal excise and transportation taxes.
- BB. **Transportation and Packaging:** By submitting their (bids/proposals), all (bidders/proposers) certify and warrant that the price offered for FOB destination includes only the actual freight rate costs at the lowest and best rate and is based upon the actual weight of the goods to be shipped. Except as otherwise specified herein, standard commercial packaging, packing, and shipping containers shall be used. All shipping containers shall be legibly marked or labeled on the outside with purchase order number, commodity description, and quantity.
- CC. **Testing and Inspection:** AHCS reserves the right to conduct any test/inspection it may deem advisable to assure goods and services conform to the specifications.
- DD. **Use of Brand Names:** Unless otherwise provided in this solicitation, the name of a certain brand, make or manufacturer does not restrict proposers to the specific brand, make or manufacturer named, but conveys the general style, type, character, and quality of the article desired. Any article which the public body, in its sole discretion, determines to be the equivalent of that specified, considering quality, workmanship, economy of operation, and suitability for the purpose intended, shall be accepted. The bidder/proposer is responsible to clearly and specifically identify the product being offered and to provide sufficient descriptive literature, catalog cuts and technical detail to enable AHCS to determine if the product offered meets the requirements of the solicitation. This is required even if offering the exact brand, make or manufacturer specified. Normally in competitive sealed bids/proposals only the information furnished with the bid/proposal will be considered in the evaluation. Failure to furnish adequate data for evaluation purposes may result in declaring a bid/proposal nonresponsive. Unless the bidder/proposer clearly indicates in its proposal that the product offered is an equivalent product, such proposal will be considered to offer the brand name product referenced in the solicitation.
