- 2. **Possible Guinan Center Expansion Quote** Anne Dean gave a brief explanation about the possibility of updating the Pit (unfinished space at the clinic in the back) for additional office space. Ingrid provided a quote from a local contractor to give the board an idea of the cost. This will be discussed at a later date.
- 3. **COVID-19** Ingrid opened with thanking Leadership for the hard work in keeping the CSB running smoothly during this time. The leadership team has been meeting weekly to discuss plans for the agency around the Corona Virus and communication to employees. Our CSB has also been meeting with local stakeholders and obtaining information from the Centers for Disease Control and Prevention and Virginia Department of Health websites. We have also been obtaining information from DBHDS. Proper handwashing and sanitizing have been encouraged and sick employees were also encouraged to stay home. Ingrid Barber gave a brief timeline of actions that have taken place within the Agency since the COVID-19 outbreak and she will continue to provide the Board updates.

Robin Sweeney ask if something could be done to recognize the front line staff working during the COVID-19 emergency. Anne Dean stated that this is something that can be looked, but we also need to evaluate our fiscal capacity.
